# 2. European and Developing Countries Clinical Trials Partnership (EDCTP)



### EDCTP – First Phase (2003-2015)

Established in 2003, with **Portugal as founding member**. FCT as representative for Portugal at the General Assembly.

Emanating from the **Article 185 (Lisbon Treaty)**: "enables the EU to participate in research programmes undertaken jointly by several Member States, including participation in the structures created for the execution of national programmes."

**Aim**: advancing a <u>concerted European response to HIV/AIDS</u>, <u>malaria and tuberculosis</u>, with a strict focus on Sub-Saharan Africa, and framed by the UN Millennium Development Goals (2000-2015).



### EDCTP – First Phase (2003-2015) (cont.)

#### Major results:

- Development of <u>8 improved medical treatments</u>, in particular for new-borns, children or pregnant/lactating women suffering from HIV/AIDS and malaria;

- Launch of <u>4 African Regional Networks of Excellence</u> promoting South-South cooperation; over 400 African researchers have been trained;

- Establishment of the <u>Pan-African Clinical Trials Registry</u> and the <u>African Vaccine Regulators Forum</u>.

**Despite success:** major epidemics-related mortality still very daunting, and demands an <u>expansion of the current programme</u>.



# EDCTP 2 (2014-2024)

EDCTP-2 builds on the upcoming Framework Programme for Research and Innovation (**Horizon 2020**).

European Commission's co-funding proposal on the table: **683 million Euro for 2014-2024**, corresponding to equal amount allocated by EDCTP participating states altogether.

**Objective:** Acceleration of the development of new or improved tools (drugs, microbicides, diagnostics and vaccines) against poverty-related diseases (HIV/AIDS, tuberculosis, malaria and **NIDs**) in partnership with sub-Saharan Africa, by provision of a critical mass of resources to support clinical trials.



# EDCTP 2 (2014-2024) (cont.)

#### **Specific Objectives:**

- To accelerate research and development of new or improved diagnostics, drugs, microbicides and vaccines against HIV/AIDS, tuberculosis, malaria and **NIDs**;

-To coordinate the European national programmes to effectively <u>work in</u> <u>synergy and in mutual partnership with sub-Saharan African stakeholders</u> in conducting relevant clinical trials for the development of the tools to fight HIV/AIDS, TB, malaria and **NIDs**;

- To develop and strengthen the capacities in sub-Saharan Africa to ensure that the relevant clinical trials are conducted using best practice;

- To develop closer partnerships with the pharmaceutical industry and other third parties to more effectively deliver the objectives of the programme.



### Programme Implementation and Activities

<u>Activity Area 1: Disease-specific priorities for clinical trials and health</u> <u>services/optimisation research</u>

# Prioritisation of Calls for Proposals for NID projects:

- Treatment (evaluation of novel drugs and drug combinations in advanced clinical stages);
- Diagnostics (evaluation of diagnostic products);
- Prevention (candidate vaccines testing);
- Implementation research.

# 3. Portugal in EDCTP-2



### Portugal in EDCTP-2

Attribution of **200.000 Euro annually for 10 years** – in cash or/and in kind – approved by the Secretary of State for Science.

#### **Principles of participation:**

- Building on capital generated by the Portuguese scientific community throughout the last 20 years;

- Collaborating with manifold partners with different capabilities (public and private, European and African);

- Enhancing <u>African participation</u>, in terms of proactive engagement in common projects (research, capacity building...) and division of costs.



## Portugal in EDCTP-2 (cont.)

#### **Priorities of Portuguese participation:**

- Focus on the Portuguese-speaking countries, in light of common interests and goals, including other European and African partners;

- Ensuring local ownership and sustainability.

#### Work Plans for EDCTP-2:

- Calculation of current in kind contribution (i.e. fellowships and research projects aligned with the EDCTP-2 programme);
- Mapping of other public and private EDCTP-2-related programmes (beyond FCT);
- Networking domestically and internationally.
